After a decisive British victory over the French at Brimstone Hill in 1782, the Treaty of Paris of 1783 granted the islands to Britain. The islands, along with Anguilla, united in 1882 and were part of the colony of the Leeward Islands (1871–1956) and of the West Indies Federation (1958–62).

In 1967, St. Kitts-Nevis-Anguilla became a self-governing state in association with Great Britain. Anguilla separated from the federation in 1980 and on September 19, 1983 St. Kitts & Nevis gained full independence and is a sovereign state in the British Commonwealth.
