In addition to the primary home, the estate includes a separate stone house of 110 m², ideal for guests, staff, or conversion into an additional rental or wellness unit.



The entire property spans 10,607 m², of which 7,667 m² lies within the building zone—an exceptional advantage in the Istrian real estate market. For buyers seeking a house in Croatia to buy with development potential, this estate offers rare opportunities.

The building zone includes several ruins of old stone houses, creating possibilities for reconstruction, expansion, or the construction of new facilities such as a swimming pool, spa center, ateliers, or additional villas, all while preserving the authentic charm of Istrian architecture.

It is also possible to purchase only the parcel that includes the villa, guest house, and swimming pool on approximately 2,200 m² of land.

The estate's key advantages include its prime location near Grožnjan, known as the “town of artists,” breathtaking panoramic views of surrounding hills and vineyards, complete privacy thanks to the property's size and positioning, and a south-facing orientation that ensures sunlight throughout the day. This is a rare property in Croatia to buy—one that offers immediate luxury living as well as outstanding long-term potential on a large building plot.

This unique estate is ideal for buyers seeking an exclusive private retreat in Istria, as well as investors aiming to create a high-end tourist complex or an expansive private residence with multiple facilities.
