The height to the ceiling of this floor is as much as 4.5m.

This floor consists of one entrance hall, a large room, a smaller kitchen, 2 offices, a changing room and a toilet.

2ND FLOOR

Currently an office space.

This floor consists of one of 2 larger offices, storage, a small kitchen and a toilet.

There is parking space for at least 10 cars around the hall.

The courtyard around the hall is modern and planned with various Mediterranean plants.
