Adriatic Sea and the mountain Velebit, known for its numerous hiking and hiking trails. The city of Rijeka, the administrative and cultural center of the Primorje-Gorski Kotar County, is 69 km away. Nearby there are numerous islands such as Krk, Cres and Rab, which delight with their many beautiful beaches and untouched nature
