The restaurant and lobby (mini coffee bar) are located on the ground floor of the building, in front of which there is a terrace that is covered and glazed, so it can be used even in case of bad weather. It has 36 seats.

The hotel has an excellent rating of 9.7 on the popular platform Booking.com, which represents an



already well-established business in tourism to the future owner!

In addition to the hotel, a large family house with an area of 180 m2 is for sale, consisting of 5 studio apartments and a private apartment. The property is ideal for hotel staff accommodation. The house is included in the price.
