### Descripción:

House of three apartments in Malinska, Krk island, 1,5 km from the sea!

Total area is 160 sq.m. Land plot is 250 sq.m.

Property was built in 2015 and renovated in 2021.

It consists of two identical apartments of 60 m2 on the ground floor and on the first floor and a studio apartment in the attic. Each apartment has its own entrance, which is reached by external stairs.

Apartment in the attic with 40 m2 of usable area is in good condition with electricity and water installations.

Apartments on the ground floor and on the first floor are 60 m2 each and consist of an entrance terrace, kitchen with dining room and living room, pantry, hallway, two bedrooms and a bathroom. In addition to parking for up to four cars, there is also a garden house with kitchen and bathroom of 9 m2 and a canopy of 18 m2 for outdoor gatherings. Although the entire house is currently connected to one electricity and water meter, there is preparation for separation by housing units.

There is also preparation for the installation of air conditioners, two for each residential unit. The carpentry is PVC with mosquito nets and aluminum shutters on the windows.

The facade thermal insulation with a thickness of 5 cm is responsible for the high energy efficiency of the house. The property was built by the owner for the family and quality materials and construction methods were used, so it represents an excellent opportunity to buy a family home, but it can also be an investment for tourist rental.

Malinska and the beautiful beaches it offers are only 1.5 km away, but the location itself can boast of a peaceful environment.
