It has a total area of 593.66 m<sup>2</sup> and is built on a plot of 1030 m<sup>2</sup>.

It consists of a total of seven two-room apartments located on the ground floor, on the first and second floors.

On the ground floor there is a spacious apartment consisting of two bedrooms, kitchen, dining room and living room, two bathrooms and a terrace. On the ground floor there is also a gym and a summer kitchen, as well as an additional toilet.

There are three two-bedroom apartments on the second floor, and the remaining three two-room apartments on the second floor.

In the yard there is a swimming pool, a sunbathing area and a parking lot with more than seven parking spaces.

The property was built in 2011, and was renovated in 2022, when the facade was renewed. The apartments are air-conditioned, PVC joinery with double-glazed windows is used, and the floor coverings are ceramic tiles and parquet.&nbsp;

The island of Pag is the fifth largest island in the Adriatic Sea by area, but with a coastline of 302.47 km, it is the most indented island in the Adriatic. It is connected to the mainland by the bridge.



The island&nbsp;Pag is known for its sparse vegetation coverage in some of its parts, which is often compared to the surface of the moon. The rocky landscape with only a few leaves of aromatic plants being grazed by sheep creates a unique impression.
