- The first floor accommodates two identical one-bedroom apartments, each featuring a bathroom, kitchen, living room, dining area, and terrace.
- The attic presents a three-room apartment with a bathroom, guest toilet, kitchen with dining area, living room, and access to a terrace showcasing a picturesque sea view.

Nestled within the garden is an auxiliary building serving as a tool room and storage space, alongside parking for multiple cars, a brick fireplace, a stone table with benches, and a variety of Mediterranean plants including olives and palm trees.

The roof requires no immediate attention, and the windows combine wood and aluminum frames. Each apartment benefits from individual air conditioning units, with the ground floor additionally equipped



with a pellet stove. The property is sold fully furnished.

Currently utilizing a septic tank, plans are underway to connect to the city sewer system come fall. The documentation is meticulously arranged and available for inspection.

Ideally located just 1500 meters from the sea and beaches, yet nestled in a tranquil spot adjacent to nature, this property offers a harmonious blend of convenience and serenity.
