Located approximately 1000 meters from the sea, the villa provides a partial sea view and the peace of a



secluded village while remaining close to the coastal attractions of the Island of Krk. This real estate opportunity is particularly attractive as the price includes VAT, exempting the buyer from the standard real estate transfer tax. Currently in the process of acquiring its energy certification, this turnkey villa combines traditional island charm with the technical standards of a premium contemporary home.
