The property features a two-story single-family home from the 1960s with a total living and usable area of approximately 240 m<sup>2</sup>. The building has never been occupied and is currently in the shell stage. The existing structure and the solid construction, including the roof truss, are in good structural condition and provide a solid foundation for completion, renovation, an addition of another story, or an extension. A new building permit was obtained for the property in 2024. In addition, current, dimensionally accurate plans—including a new survey—as well as concepts for a possible subdivision of the property are available.

Interior finishing work has not yet been carried out. The walls are exposed brick and unplastered; no screed work has been done. Installation slots have already been cut in some areas. An oil-fired central heating system is installed and operational. The basement features a small laundry room with water and sewer connections, as well as an existing electrical service connection.
