Trinity is a small village located on the southwestern coast of the island of Saint Kitts, which, along with the nearby island of Nevis, makes up the two-island nation of Saint Kitts and Nevis. This charming village serves as the capital of the parish of Trinity Palmetto Point. The parish is known for its dramatic coastline, featuring a mix of black volcanic sand beaches and rocky shores. The terrain transitions from coastal lowlands, historically used for sugar plantations, to lush, tropical forests in the more mountainous interior. The airport handles both international and regional flights, connecting Saint Kitts to destinations in North America, Europe, and other Caribbean islands.
