The second 5 star hotel Les Charmes has around 35 rooms and 2 suites in the immediate vicinity of the beach offering high end services and wellness amenities.

The third 4 star hotel Palace offers around 264 spacious rooms with sea or garden views complemented by restaurants and various sports facilities.

The fourth complex Les Villas de luxe includes independent villas with 2 to 4 bedrooms with private spaces and individual swimming pools ideal for premium clients or residential tourists.

The integrated water park offers slides a wave pool a lazy river children's play areas as well as bars and snacks.

Tourism Market Overview

Tourism in Tunisia has seen a solid recovery since 2023 with rising visitor numbers and a predominantly European and Middle Eastern clientele. Djerba remains a leading destination for seaside and family tourism with its fine sandy beaches cultural heritage and high end hotel infrastructure. The combination of hotels thalassotherapy and water parks is a differentiating asset promoting an average occupancy rate estimated at 70% during the tourist season.



Indicative financial projection

With a projected occupancy rate of 70% an average nightly rate of 120 TND per room and regular attendance over the period March to November the total estimated annual turnover for the complex including accommodation catering and leisure activities could reach approximately 18 million TND. These projections are given for information purposes only and may change depending on the commercial strategy and seasonality.
